ACTIVITY/EVENT RELEASE AND WAIVER OF LIABILITY, ASSUMPTION OF RISK, AND INDEMNITY AGREEMENT ("AGREEMENT")

I understand the nature of this Activity and that I am qualified, in good health, and in proper physical condition to participate in such Activity. I acknowledge that if I believe event conditions are unsafe, I will immediately discontinue participation in the Activity and inform coordinator. I fully understand that this Activity involves risks of serious bodily injury, including permanent disability, paralysis, and death, which may be caused by my own actions, or inactions, those of others participating in the event, the conditions in which this event takes place, or the negligence of the "releases" named below; and that there may be other risks either not known to me or not readily foreseeable at this time; and I fully accept and assume all such risks and all responsibility for loses, cost, and damages I incur as a result of my participation in the Activity.

By completing this form I hereby apply to Ray & Dortha Marty and Tim & Felicia Eyre (thereinafter "Camp R&R") to participate in the event indicated. By my signature below, I certify that I have read, understood and accept the following stipulations and waiver.

I expressly assume financial and/or legal liability for all risks and injury to persons who accompany me on this event including family members, guests, friends and acquaintances, and all other persons who accompany me.
